Now is a Good Time to Review Access Controls for Your Business

Your Business Online Banking Account is a critical part of your operations, so it's important to periodically review and update access controls:

- Make sure each individual has their own login to any systems with profiles set up based on what tasks or transactions they may be responsible for.
- Regularly update your passwords and be sure not to share them with others.
- Monitor system access for past employees or vendors, and be sure to remove or limit their access as soon as their purpose for access is complete.

What are my retirement plan options as a small business owner?

If you are self-employed or own a small business and you haven't established a retirement savings plan, what are you waiting for? A retirement plan can have significant tax advantages: your contributions are deductible when made, your contributions aren't taxed to an employee until distributed from the plan, and money in the retirement program grows tax deferred (or, in the case of Roth accounts, potentially tax free). Retirement plans are usually either IRA-based (like SEPs and SIMPLE IRAs) or "qualified" (like 401(k)s, profit-sharing plans, and defined benefit plans). Qualified plans are generally more complicated and expensive to maintain than IRA-based plans because they have to comply with specific Internal Revenue Code and ERISA (the Employee Retirement Income Security Act of 1974) requirements in order to qualify for their tax benefits. Qualified plan assets must be held either in trust or by an insurance company.
